# **BOARD MEETING HIGHLIGHTS - November 16, 2024**

- Website: We have found a webmaster (CC Design Pros) who is building us a new website, which
  will be up and running soon after the Annual Meeting, allowing online payments. For now, new
  members and renewals must pay by cash or check in the Blacklake Community Room (M-F from 9
  AM to 12 PM), or left outside in the drop box.
- **Financial**: With increased memberships and lower PG&E rates, we are able to start a modest reserve fund. However, we must raise membership fees by \$25 to cover increased maintenance.
- Water Temperature: We will try to maintain the pool water temperature close to 83° for the winter months. The spa will remain at 103°.
- **Pool Hours**: SLO County requires that all swimming pools close after dark. Please note that the sheriff will be called for anyone trespassing at night.
- **Contact Numbers**: Now located on both outside gates. <u>For medical emergencies, dial 911</u>.
